Commissioner McGowan read the following:

In 2013, the Bunbury Wellington Group of Councils (BWGC, now titled the Bunbury Geographe Group of Councils) which included the Shire of Donnybrook Balingup, shared resources for the procurement of suitable waste management services specific to the needs of each participating local government. The awarded contracts of the time are now due to expire on 30 June 2023 and new services need to be appointed.

In the last decade, there have been significant changes to the waste sector that have resulted in many improvements to the general practices of waste management in an effort to provide more sustainable options and processes, and shift towards a more genuinely 'circular' waste economy. However, there have also been a number of market changes that have resulted in increased costs to the provision of waste management services, particularly in the recyclable processing space.

In anticipation of the upcoming expiration of the relevant waste management contracts and the inevitable variations to the current rates, a number of south west local governments formed the South West Regional Waste Group, and agreed to work collaboratively to jointly procure waste services for the region. The participating local governments include:

- City of Bunbury;
- · Shire of Harvey;
- Shire of Collie;
- Shire of Capel;
- Shire of Donnybrook Balingup;
- Shire of Bridgetown Greenbushes; and
- Shire of Nannup.

For the past 12 months, whilst each local government within the SWRWG has been committed to prioritising their district's individual waste service needs and resources, the intent of the collaborative tender process was to obtain the best value for service through the weight of a combined, and agreed, regional approach. The SWRWG is a great example of how local governments can work together to provide high quality, value-formoney services for the community.

In January 2023, the City of Bunbury, on behalf of the South West Regional Waste Group, issued a Tender (Tender COB/5427) with a view to engage a suitably qualified and experienced contractor to undertake a range of waste management services within each of the participating local governments. Three contractors made submissions and a total of 11 different price models were assessed.

The final price model and associated costs for waste management services for the local governments in the South West Regional Waste Group will be completely dependent upon the outcome of each individual Council decision; which are currently being considered, based on the respective meeting dates of each participating local government.

Therefore, the resolution from today's meeting should remain confidential until such time that all Council's in the Group have resolved a decision on the appointment of a contractor for their respective waste management services, and a contract is awarded. This is to ensure the process is not compromised by the release of potentially commercially

sensitive information and allows for the South West Regional Waste Group to continue to work towards the best outcomes for their respective communities.

I'd like to thank all the staff involved and the City of Bunbury for facilitating the tender process.
