I will be paid within the payment terms and conditions of the Shire in line with this document and appropriate Shire Purchasing Policies for up to 50% of cost of the approved works as indicated on the landowner agreement form, which will be provided separately. No additional funding will be provided in the instance that the final invoice exceeds the amount on the landowner agreement form.
- i. Payment will be initiated upon presenting the appropriate Shire a copy of a relevant, complete, and **FULLY PAID** Contractor tax invoice. The Shire holds no responsibility for payment to any contractors.
