The policy to provide indemnity in respect of both injury to person and damage to property in the usual terms and such policy to include (but without limiting the generality of the foregoing) loss or damage to property not owned by the licence holder but under the physical or legal control of the licence holder and contractual liability and such other risks (if any) as the Council might reasonably nominate at the time of granting of the Licence.
