## AIM, SCOPE & OBJECTIVES

---

### 1 AIM OF THIS BUSH FIRE RESPONSE PLAN

---

The aim of this document is to provide for a strong capability, to protect assets and people within the Shire of Donnybrook-Balingup from fire.

---

#### 1.1 Scope of this Document

---

The scope is the whole of the Shire of Donnybrook-Balingup, including the townships of Donnybrook, Balingup, Kirup and the settlements of Lowden, Mumballup, Noggerup, Argyle, Mullalyup, Ferndale and Thomson Brook.

---

#### 1.2 Objectives of this Document

---

1. To provide a set of fire management arrangements supportive of the overall protection of the community (including assets) of Donnybrook-Balingup from fire.
2. To detail the community context, for any arrangements to apply, including contacts and response resources.
3. To detail community elements at risk from fire, likely causes of this risk and triggers for escalation of response efforts to manage fire.
4. To determine differences in levels of risk, throughout the Shire.
5. To provide arrangements for incident management, including facilities, competent personnel and inter-agency cooperative arrangements.

## 2 SHIRE OF DONNYBROOK - BALINGUP LOCAL GOVERNMENT AREA

### 2.1 Description of Locality and Fire Risk/Hazards

The Shire of Donnybrook-Balingup covers an area of 1560 square kms in the southwest of Western Australia.

The Shire is serviced by the South Western Highway from Bunbury, and the Donnybrook-Boyup Brook Road from Boyup Brook. Donnybrook-Balingup is bounded by the Capel, Busselton, Nannup, Bridgetown-Greenbushes, Boyup Brook, Collie and Dardanup Shires.

Approximately 50% of the Shire area is under control of the Department of Parks and Wildlife. Land under this control consists of hardwood forests, pine plantations, Flora and Fauna Reserves and Forest Conservation areas.

There are a number of other reserves vested in Government Instrumentalities including Vacant Crown Land. The remaining land is freehold land which includes urban areas, rural residential, intensive cultivation, general farming pastoral, hardwood and softwood plantations and tourist uses.

Over recent years the development of rural residential subdivisions and rural townsite expansion, particularly in the Preston town site, has changed the basic fire protection requirements in these areas, and has the potential for further change as land is developed.

## 2.2 Schedule of Existing Brigade Equipment

---

## 2.3 Fire Suppression Requirements

---

### TOWNSITES

A fire hydrant plan is in existence in the Donnybrook town site and the area is serviced by the WA Fire and Rescue Service. The reticulated areas of Balingup, Kirup and Mullalyup are partially serviced by hydrants.

Fire appliances servicing these towns (including Preston) must provide a dual Structural/Bush Fire role and be capable of carrying sufficient water. Appliances to protect those areas should be equipped to Bush Fire Services Structural Fire Standards.

In general 3.4 Fire Appliances should be provided as this further allows for dual structural/bush fire capability.



## BUSH FIRES

The Shire is well equipped with medium and heavy tankers located in, Argyle/Irishtown, Balingup, Ferndale, Kirup, Lowden, Mullalyup, and Thomson Brook.

It is recognised that there is a need to continually upgrade these resources on a priority and needs basis, with particular reference to older appliances. The importance of light tanker appliances as first response units is acknowledged, and the provision of these units needs to be available to each Brigade.

---

### 2.4 Population Growth and Development

---

Conservative estimates based on Census figures for the Shire of Donnybrook-Balingup suggest an annual growth rate of approximately 2.6%.

Areas of the Shire showing 2016 Census population figures are listed below.

### 2.5 Brigade Equipment and Maintenance

---

Brigade equipment throughout the Shire is considered to be maintained in **good to very good** condition. It is important that Council adopts a policy of upgrading equipment in high fire risk areas to ensure that no appliance is kept for so long that it becomes unreliable or unsafe, with equal or better than the appliance at present.

All equipment operated by brigades must undergo regular inspections and service where necessary, to be carried out by qualified and approved organisations or personnel.

---

### 2.6 Amalgamations and Rationalisation

---

The recent amalgamation of some brigades has reduced the number of brigades from 16 to 11. It is imperative that Council continually reviews brigade structure and that future amalgamations be kept under consideration.



## 2.7 Communications

The WAERN (West Australian Emergency Radio Network) radios, have been in operation for several fire seasons.

We are however running a dual system incorporating the current channel 37 system and this should continue. This is termed cross banding.

Note; talk around or simplex will NOT cross band.

The Donnybrook-Balingup Shire Bush Fire Brigades have been allocated radio communications Channel 106 VHF High Band and also channel 144 for Balingup area.

Channels 361 to 369 are available as simplex.

Again only channel 106 is cross banded to channel 37, so initial response will only be channel 106. Any transmissions from channel 144 will not be received on the old radios.

Currently the old system is

- (A) The Donnybrook-Balingup Shire Bush Fire Brigades have allocated radio communications Channel 37 VHF Low Band TTR and Channel 46 VHF Low Band simplex.
- (B) The Department of Parks and Wildlife also operate a VHF Low Band TTR system.

This may be phased out eventually.

The Donnybrook-Balingup Bush Fire Network operates a very efficient radio communication facility with some 50 radios in operation. Regularly, between 40 and 45 stations participate in Radio Schedules.

Network requirements will need to be assessed in the near future.

The Police, State Emergency Service and St John's Ambulance operating from Donnybrook currently have Bush Fire Radios in their vehicles, until further notice, St John's and the Police will be contactable via old channel 37 and channel 106. State Emergency Service communications will be via the new WAERN radios on 115 UHF or VHF Simplex 359.

A default multi-agency Radio Operations Plan has been developed and agreed to by the Donnybrook/Balingup emergency services. It is included into these arrangements on page 19. A copy is laminated and placed into each of the fire-fighting appliances within the bush fire brigade fleet.

An updated communications Plan will be forwarded to all Brigades and FCOs by November 30<sup>th</sup>.

---

## **2.8 Brigade Station/Headquarters**

---

Fire units at Argyle/Irishtown, Balingup, Ferndale, Kirup, Lowden, Thomson Brook, Mullalyup, Mumballup, Munro and Upper Capel, are housed in purpose built stations. Only the Beelerup 1.4 is housed privately in a farm shed.

This strategy recognises that to be eligible for equipment subsidies fire appliances must be housed in approved station headquarters.

Appendix 10 details the planned forward capital works for Bush Fire Brigade Stations within the Shire.

---

## **2.9 Call Out Systems**

---

In this Shire, the organisation is very effective. Brigade boundaries are for administration purposes and there is good interaction between Brigades. The Radio Telephone call out system currently in use works very effectively.

The Department of Parks and Wildlife (DPaW) work closely with the brigade network and a mutual assistance relationship exists.

---

## **2.10 Fire Control Officers**

---

Presently, there are 16 Fire Control Officers within the Shire of Donnybrook-Balingup and 15 have attended the Fire Control Officers course.

Due to the isolated pockets of settlement, large areas of State Forest and the hilly terrain of the Shire, this is considered as a minimum requirement to provide adequate cover.

---

## **2.11 Training Recommended**

---

Membership in most rural, urban, settlement areas is sufficient to maintain properly structured brigades, however most areas would appreciate additional active members.

A training programme is operating and all brigades are being encouraged to appoint training co-ordinators. The recommended Shire levels of training for each Brigade are included in the Brigade Prescriptions at Appendix 5.

Individual Module Training Sessions have been conducted since 2001 and have proven to be an effective way of providing training to Brigade members, this is an ongoing method enabling trainers to target missed training.

Local trainers are trained to DFES standards to deliver Induction, AIMS Awareness, Introduction to Fire Fighting and Bush Fire Fighting.

The continuation of this program is to be encouraged.

## 2.12 Financial Management

---

The resources that provide ongoing (long term) fire protection are to be derived from the following sources:

Emergency Service Levy (ESL), the Local Government Grant Scheme.

It is recognised that Local Government may be required to make up shortfalls in the current LGGS System.

For major wildfires, assistance is available through the DFES Regional Office through SAP 12. The trigger for this assistance is through the Regional Duty Coordinator on 9771 6820. A request will be considered on its merits at time of request.

## 2.14 Environmental & Cultural Issues

---

*A registry of important sites to local aboriginal people is available through the Shire and the BRMS system. It is also available from the Department of Aboriginal Affairs. Such significant sites should be treated with the appropriate level of respect.*

The use of fire-fighting foams (BFFF) and retardants should be avoided in and around water catchments and riparian zones.

A register of Rare Declared Flora and Fauna, is managed by DPaW.

European heritage sites can be found on the 'Municipal Heritage Settlements Register' available through the Shire. These too, need to be considered and given attention in all hazard management and emergency activities.

## 2.17 Access

---

### STRATEGIC FIRE ACCESS TRACKS

The Shire of Donnybrook-Balingup recognises the need for the prevention of bush fires as part of its responsibilities in land use planning. The Shire incorporates the principles of land use planning in rural areas jointly developed by the Western Australian Planning Commission (WAPC) and DFES in assessing all applications for development of land. Reference should be made to the document "Planning for Bush Fire Protection" DFES – December, 2002)

In addition, the Shire has approved Fire Management Plans for some special rural and residential estates.

Landowners in the following special rural and residential estates are required to comply with the requirements of the approved Fire Management Plans for that estate: Marshall Road Estate, Meldene Estate, Argyle Heights, Tallowood Estate, and Brazier.



---

## 2.18 Water Resources

---

The townships of Donnybrook, Kirup, Balingup and parts of Mullalyup are serviced by fire hydrants and reticulated water supplies. The Donnybrook Volunteer FRS regularly maintains the hydrants within the Donnybrook town site and maintains a data base of their locations. The remainder are the responsibility of the Shire. The remainder of the Shire relies upon water supplies other than hydrants.

Note: Balingup, Mullalyup and Kirup have limited fire hydrants and pressure and should not be relied on.

Other than private domestic water supply tanks and dams, a network of permanent water supply points is managed throughout the Shire. These are indicated on the Computer Operational Graphics (COG) maps, held by Brigades and DPaW.

The symbol for these is the standard

## 3 INCIDENT MANAGEMENT

---

### 3.1 Incident Notification

---

#### NOTIFICATION OF WILDFIRES

- All fires should be reported on 000 from the public to the Shire of Donnybrook-Balingup, 000 will then notify relevant person.
- Local brigades will be activated internally by brigade contacts. The Shire on notification of wildfire will activate brigades as necessary and inform CBFCO of call out.
- The DFES Regional Duty Coordinator is to be notified when two Brigades and/or 4 appliances are deployed to an incident on **9771 6820**.

#### COORDINATION PROCEDURES

Coordination of bush fire suppression efforts will be based on the principles of the Incident Control System and authority is defined by the relevant Act (Bush Fires Act, CALM Act or Fire Brigades Act).

The Chief Bush Fire Control Officer of the Shire of Donnybrook-Balingup has the authority under the Bush Fires Act to ensure that all brigades are managed to provide the most effective response to all incidents within the scope of the Bush Fires Act.

Requirements and resources above those of local brigades will be requested via the Regional Fire Incidents Response Plan from the Department of Fire and Emergency Services in Manjimup.

## **INCIDENT CONTROL**

The CBFCO (or delegated officer) shall be the Incident Controller at all major fires and will establish a Forward Control Point. Note 3.3 Handover Control Agreement for larger type fires.

Control of bush fire suppression efforts will be based on the principles of the Australian Inter-service Incident Management (AIIIMS-ICS) and authority is defined by the relevant Act (Bush Fires Act, CALM Act or Fire Brigades Act).

The Chief Bush Fire Control Officer of the Shire of Donnybrook-Balingup has the responsibility under the Bush Fires Act (1954), to ensure that all brigades are managed to provide the most effective response to all incidents, within the scope of that Act.

As Incident Controller, the CBFCO shall have overall management of the fire incident. In the absence of the CBFCO, the Incident Controller shall be a Deputy CBFCO or Senior Fire Control Officer.

---

### **3.2 Call-out Procedures**

---

The Bush Fire Organisation will respond to all reported incidents with trained Brigade members, with the required PPE, appliances and communications equipment. Back up would be requested as required, upward through the Bush Fire Brigade chain of command.

---

### **3.3 Handover Protocols**

---

In the event that a more senior officer of the LG Brigade network attends, he/she may assume control of the incident from the current OIC.

In the event that the fire is in, on or near DPaW estate, a Forest Officer may take control (Bush Fires Act (1954) section 45) of the incident from a Brigade Officer.

A handover of control agreement exists between DFES and Donnybrook-Balingup Shire (Bush Fire Act (1954) section 13(4)). Under this agreement, the Shire may seek to pass over control for a major bush fire, to DFES staff.

### **3.4 Initial Appliance & Resource Turnout**

---

## **INCIDENT CLASSIFICATION FOR LOCAL GOVERNMENT BUSH FIRE BRIGADES**

Brigades will respond according to their Brigade Response Plan and advice given by the Incident Controller via the radio network.



They will be related to the Brigade response profile, as detailed in the table included into each of the individual Brigade response plans.

Incident response will be indicated as a result of consideration of the following factors:

- Fire Danger index (FDI) for the forecast day,
- Nature of the asset at risk,
- Size of fire at time of notification.

### 3.5 On Call Rosters

The On-call arrangements for the fire-fighters in the Brigades for Donnybrook-Balingup, is self-managed at Brigade level. Officers of the Brigades take the responsibility to ensure an appropriate turn-out with respect to the incident requirements and/or the FDI.

### 3.6 Current List of Members

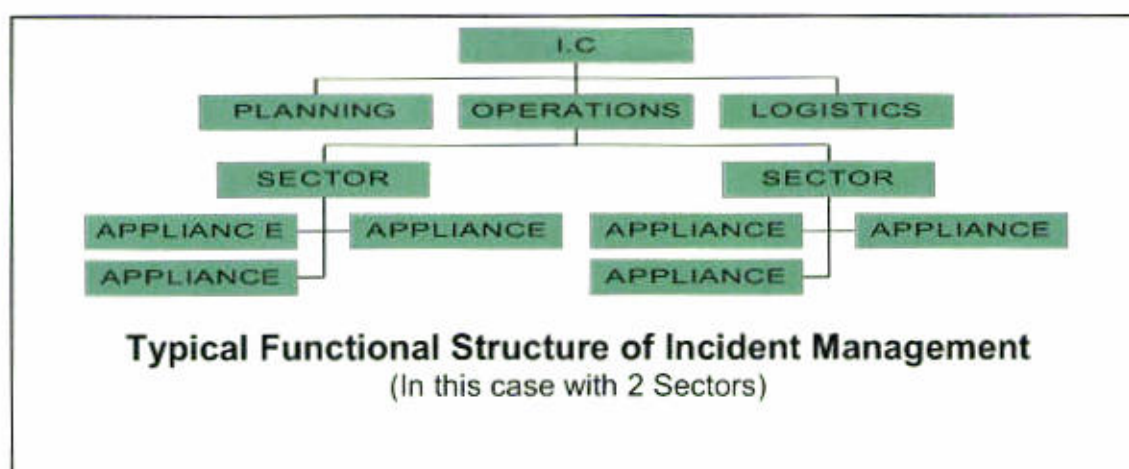
Refer to the LG/Brigade records or DFES databases, for the current records including Academy for training competencies.

### 3.7 Australian Interagency Incident Management System (AIIMS)

#### INCIDENT MANAGEMENT STRUCTURE

The BFB resources within the Shire use the AIIMS for incident management. They have received and continue to receive, training through the 'Introduction to AIIMS' and 'AIIMS Awareness' training from DFES.

DPaW also use the AIIMS and WA Police are also beginning to embrace the system, both using the same training packages.



### 3.8 Incident Control

For small, **low complexity incidents**, the **first arriving officer** shall assume command for the incident and manage all functions of the AIIMS, delegating wherever necessary. They will also manage for any escalation that may become necessary, following the Shire's bush fire management protocols.

The **CBFCO** shall be the Incident Controller at all **major fires** and will establish a Forward Control Point. In the absence of the CBFCO, the Incident Controller shall be a Deputy CBFCO or Senior Fire Control Officer.

As Incident Controller, the officer shall have overall management of the fire incident and any resources applied to incident management at that time.

#### 3.8.1 Level One Incidents

Initial responding officer will maintain control. It is conceivable that this officer may maintain logistics and planning functions, but may pass operations to another officer, if the incident requires this.

A report to the CBFCO will be made with SitReps, for DFES SOP B1.

The incident will probably be made safe within less than 8 hours, with minor disruption to community.

Local Brigade resources will be sufficient to contain and patrol until 'safe'.



---

### 3.8.2 Level Two Incidents

---

The escalation to a 'level II' incident would be obvious when the initial response is insufficient to manage the incident, due to its scale or complexity. It is conceivable that the competencies required for the control of the incident, would be such that a senior officer (CBFCO) would be required to relieve the first arriving officer, who may take a lesser role in the incident management structure.

All level two & three incidents must be reported to the Shire CEO or Ranger.

A full Incident management (IMT) structure will be implemented, using the AIMS. Officers should be fully competent (formal training and experiential) in the roles that they will occupy, at the level that they are expected to operate. The Shire's training competency profile plan should be consulted.

It is likely that the time to control may be greater than 8 hours (potentially days) with significant community involvement. It is likely that the pre-determined 'triggers' for LEMC/IMG involvement would be reached.

It is also likely that significant external resources would be required to supplement local ones. The DFES Regional Duty Coordinator should be involved, if only for coordination functions. Reporting to the Regional DFES Office should be regular and accurate.

If it is apparent that the incident may escalate beyond local resources, or become more significant in terms of losses, consideration should be made for the actioning of the Handover of Control to DFES protocols (*Bush Fires Act (1954) – section 13(4)*).

---

### 3.8.3 Level Three Incidents

---

For an incident of this size and/or complexity, the OIC should have already established contact with the Regional Duty Officer of DFES for assistance. At this stage, significant assistance should have been gained from DFES and resources from surrounding local government resources. It would be prudent to seriously consider hand over of control to DFES (*Bush Fires Act 1954-Section 13(4)*) through the existing MOU, should this not have already occurred. This assistance would be dependent upon DFES having sufficient resources to be able to assist.

The OIC and the remainder of persons within the IMT, should have sufficient competencies (formal training and experiential) for any functions that they are to perform.

It would be necessary that support would be available through the LEMC (IMG) for any or all of the community affected by this incident. Due to the nature of the incident size, it is probable that the DEMC (OAMG) would also be active in the coordination support to the LEMC (IMG).

### 3.9 Mutual Aid Arrangements & Plans Across Districts

The CBFCO has the authority to dispatch appliances subject to the availability of the brigades. It is recognised by the CBFCO that the protection of lives and property within the Shire has priority when considering allocation of fire appliances outside the Shire boundaries. The Shire CEO is to be advised in all cases.

### 3.10 Handover MOU

Under section 13(4) of the Bush Fires Act (1954), local Government may pass control of a significant event to DFES. An agreement to this effect was signed by CEO Donnybrook and the CEO of DFES on the 17<sup>th</sup> of December, 2004 and 18<sup>th</sup> of January, 2005 respectively.

The level of assistance being available from DFES, is dependent upon DFES's existing available resources.

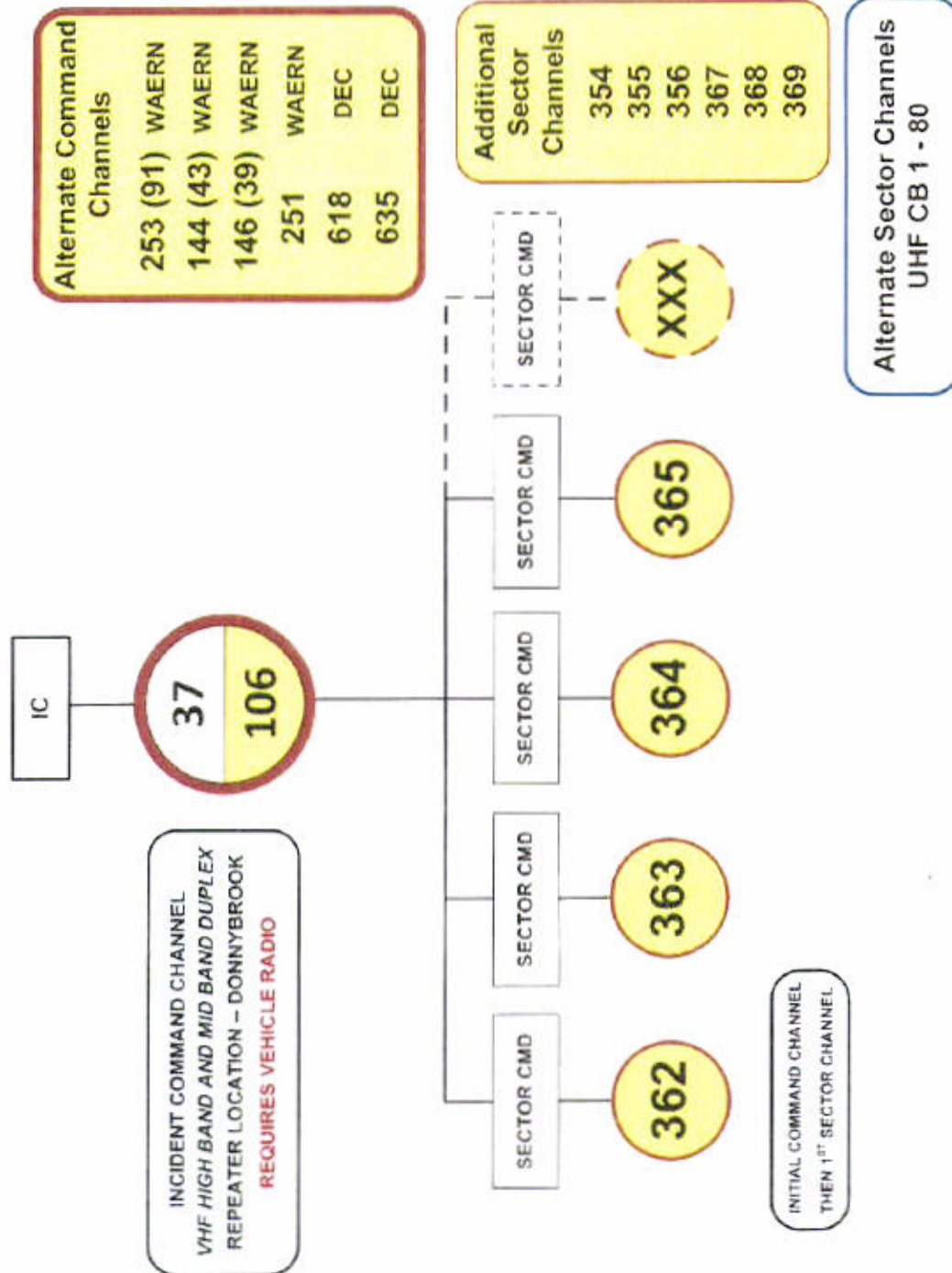

### **3.12 Control Point Arrangements**

Routine fire operations are generally controlled / managed through the provision of Forward Control Points (FCP). This may be the OIC's vehicle, or more formal through the provision of a dedicated facility or vehicle (SW Regional Incident Control Vehicle – ICV is available through the Regional Duty Officer). Where the incident becomes more significant, it may be necessary to establish the Shire's Local Emergency Operations centre (LEOC).



## **DONNYBROOK FIRE EMERGENCY OPERATIONS CENTRE**

The Fire Emergency Operations Centre will be at the Donnybrook-Balingup Shire in Bentley Street, Donnybrook.

Donnybrook Local Emergency Operations Centre is in the SES Headquarters on Bentley Street, Donnybrook.

Communications to the Brigade and other fire agencies will be via VHF radio and telephone.

Communications with SES will be by VHF compatible portable or telephone available from the Shire Office.

Communications to the Donnybrook Police will be via telephone or VHF compatible radio.

Communications at wildfires will be via WAERN CHANNEL 106 or simplex channel 369.

---

### **3.13 Coordination Centres**

## INCIDENT MANAGEMENT GROUP (IMG)

In the event that the LEOC is not established (nor is likely to be) for a control centre, this facility may be available for the IMG.

The Incident Management Group will be formed in support of the incident management and will be formed through consultation between the HMA and the WA Police. It is likely to consist of members of the LEMC who are involved by virtue of their expertise. Other members may be co-opted, as required.

The main focus of the IMG is to ensure community interests are served and that they are informed of the situation, as required. The IMG is a coordination organisation, for the provision of effective support to an incident management team (or multiple – within an area).

---

### 3.14 Air Support

---

Air support to assist with fire-fighting operations, is available from DFES and/or DPaW. **Water Bombing** aircraft and the DPaW spotter (complete with Air Attack Supervisor (AAS)) is available through **DBCA District Duty Officer** on **9771 6820**.

**Air reconnaissance** aircraft can be requested through the **DFES Regional Duty Coordinator** on **9771 6820**, but will need to be prioritised against state-wide priorities.

The **RAC Rescue** (medical support) helicopter is available to assist with urgent rescue tasks by calling the **DFES ComCen** and requesting the DFES Duty Director to authorise its deployment. Contact for the Duty Director is via **1800 198 140**.

---

### 3.15 Fire Suppression Strategies

---

The fire protection strategies for the Shire of Donnybrook-Balingup Fire Services shall reflect the accepted community values as follows:

1. Protection of life,
2. Protection of property,
3. Protection of environmental/heritage values,
4. Containment of the incident within strategic firebreaks, and
5. Extinguishment of the fire.

The application of these strategies will be determined by the CBFCO having regard for the existing fuel levels, topography and available resources.



The main strategy for any fire in the area that cannot be quickly suppressed and is likely to escalate, is to contain it within the defined boundaries of the relevant compartment, with minimum use of earth moving machinery.

Water bombers will be turned out at the first report of a fire when response arrangements are in place.

Water bombers should also be used where such action minimises the use of earth moving machinery, and enhances containment of a fire within established compartment boundaries.

Any alternative strategy aimed at more direct attack on the fire should be considered only after the main strategy, concept has been addressed.

A complete map set of the Donnybrook-Balingup area including aerial photographs are contained within the Emergency Services Directory (ESD) and will be distributed to all operational fire service units.

---

### **3.16 Adopted Standard Operational Procedures**

---

Donnybrook-Balingup recommends all of the Bush Fires Board SOPs from 1994 (specifically B1-B12, LA1-LA13).

---

### **3.17 Traffic Management Protocols**

---

Traffic management needs to be considered whenever fire-fighting activities (including hazard reduction and training activities) occur within the Shire. Any activity that causes fire-fighters or the motoring public, to be at an increased risk, needs to include a traffic management plan.

Training is available to qualify traffic management persons to control or divert traffic. It is Main Road's WA policy that such people be engaged to design, implement and manage traffic for routine, planned events.

In the case of fire or emergency activities, fire officers may cause roads to be shut (*Bush Fires Act (1954) – section 39g*), for the protection of fire-fighters and/or road users.

Traffic management for emergencies can be arranged by Main Roads TNC Contractor – Southern Road Services, by telephoning **9724 9724**, or Main Roads on **1800 800 009**. They will respond but, with a delay where the road would remain closed. WA Police may be contacted to affect the road closure in the interim.

Guidelines for road safety for planned short duration delays (ie, hydrant marking), are indicated in DFES – SOP 35, Safe Working on Roadways. These shall be followed by Donnybrook-Balingup Brigades for such events.

### 3.18 Safety Protocols

For activities on, or travelling to, the Fire-ground and on training activities, the following SOP apply:

Protective clothing matrix

Emergency Type		Protective Clothing required (BFB)
Bush Fire		Full Protective (level 1) c/w goggles, boots (leather-upper), helmet and gloves.
Structural Fire	Defensive	As above
	Offensive (internal attack) Fire & Rescue Service	Full Protective (level 2) c/w goggles, boots (leather-upper), helmet and gloves. Breathing apparatus may supplement for offensive attack.

### 3.19 Resources Deployment

- Brigades respond as per individual brigade's response plan.
- If attending appliances are insufficient to control the fire, contact the CBFCO who will dispatch other brigade units as required.
- CBFCO may activate the Donnybrook LEMC, if required should the CBFCO deem it necessary for resources from outside of the Shire be required, contact should be made with the Regional Duty Officer of DFES, for assistance

### 3.20 Bush Fire Refreshment for Fire Fighters

When a fire crew has been called to a fire at least 2 hours before a meal period and it has been established that they will still be required for at least 2 hours after the meal period, Council will provide the refreshments required via the LGGs Levy, food and drink (not including alcoholic beverages).

For continuation of firefighting duties after this period, refreshments will be supplied at the various meal periods.



### **Information Required**

The following information will be required for ordering of meals.

- The number of personnel
- Type of meals
- Time to be provided
- Minimum time required after activation
- Location
  - a) forward control point
  - b) fire line
- Drinks
  - a) number
  - b) type

---

### **3.21 Post Incident Procedures**

---

For level I incidents, a hot-debrief is required at the local station, with any recommendations entered to the fire report. This report is to be submitted to the LG, who may in turn, forward to the Regional office of DFES. Any recommendations need to be considered by LG and if appropriate, passed on to BFAC for their consideration.

For incidents Level II or above, a formal IAP should be conducted using DFES's Policy 54 or BFB SOP LA5 templates.

Where an accident, injury or near miss occurs, this needs to be considered carefully, following BFB LA6 and any LG insurance requirements. LG needs to be notified, through a brigade executive officer.

---

### **3.22 Funding Arrangements & Protocols**

---

For major wildfires assistance is available through the DFES Regional Office through SAP 12. The trigger for this assistance is through the Regional Duty Coordinator on 9771 6820 at the time of the incident (before any money is expended). A request will be considered on its merits, at the time of request.

---

### **3.23 Brigade Rules**

---

The Shire of Donnybrook-Balingup has adopted Bush Fire Brigades Local Laws. The First schedule to these Local Laws contains the Rules Governing the Operation of Bush Fire Brigades.

A copy of these Rules is outlined in appendix 2.

---

## **4 EMERGENCY MANAGEMENT**

---

---

## **4.1 Evacuation Procedures**

---

### **EVACUATION CATEGORIES**

In the event that a fire incident escalates to that extent that evacuation procedures must be implemented, these procedures shall be carried out in accordance with the Shire of Donnybrook-Balingup local emergency management arrangements. The welfare of persons evacuated will be met, in accordance with the provisions of the Shire of Donnybrook-Balingup Welfare Plan.

The decision to evacuate is made by the HMA Incident Controller and implemented by the WA Police Service; there are two categories of evacuation, namely Immediate and Planned.

### **IMMEDIATE EVACUATION**

Evacuation of this kind will require an instant decision by the Hazard Management Agency. The Incident Controller should advise the WA Police Service Liaison Officer of:

1. The urgency of the evacuation
2. The estimated area of evacuation
3. The likely duration of the evacuation
4. The safe direction for evacuation

The WA Police Service Liaison Officer should then arrange the immediate evacuation of the area to any convenient safe area. It should be noted statistics show that more than 25% of people will ignore this instruction and will, in preference, proceed to friends or relatives. The remaining evacuees can then either be allowed to return to their homes once the all clear is confirmed, or, in the case of a longer duration of evacuation, transported to a designated Welfare Centre as nominated by the Welfare Coordinator (DCD).



## PLANNED EVACUATION

Where circumstances permit, an orderly evacuation may be achieved. Once again a significant proportion of the evacuated population will make their own accommodation provisions.

## EVACUATION CONSIDERATIONS

The State Emergency Management Committee (SEMC), Policy Statement No 5 Bushfire Evacuation Decision Policy (Annexure F), provides direction to the WA Police Service Liaison Officer.

## WELFARE ORGANISATION

Welfare Co-ordination Centre – The Welfare Coordinator will operate from a welfare co-ordination centre located as detailed below.

There may be two types of Welfare Centres established to assist victims of bushfire. These are:

- **Welfare Assembly Centres** – Established within or near the disaster area to meet the immediate needs of disaster victims and to disseminate information. A welfare assembly centre is to provide the following facilities:
  1. Emergency Clothing/Covering
  2. Drinks and Meals
  3. Registration
  4. Shelter

The locations of welfare assembly centres to be used will be determined at the time in accordance with the effects of a particular threat.

- **Welfare Centres** – Established as an emergency facility to provide shelter, food, clothing and all other welfare services until alternative arrangements can be made. A welfare centre is to provide the following facilities:
  1. Administration Manager
  2. Emergency Feeding
  3. Emergency Clothing
  4. Personal Services
  5. Registration and Inquiry
  6. First Aid
  7. Emergency Accommodation
  8. Personal Hygiene and Sanitation

## 4.2 Public Broadcasting Procedures

Information shall be supplied to these outlets by way of press releases, which shall be endorsed by either the Shire president or the Chief Executive Officer.

All press releases shall also be displayed at all libraries within the shire, the notice board at the Shire administration Centre and be posted on the Shire website, [www.donnybrook-balingup.wa.gov.au](http://www.donnybrook-balingup.wa.gov.au)

1. The Incident Controller is responsible for the management and authorisation of media releases during an incident. The Shire of Donnybrook-Balingup, DFES and DPaW will work together, to coordinate information released to the media and define a single point of contact.
2. The Department of Fire and Emergency Services (DFES) may dispatch a Media Liaison Officer in the circumstances to work for/on behalf of, the Incident Controller, in association with the local government. Media Liaison Officers can be requested through the District Manager/On Call Officer or via the Regional Duty Officer (on 9771 6820). In these circumstances, the Media Liaison Officer (MLO) is responsible for coordinating the actions of the media and ensuring their safety, while on the incident ground. Information provided to the media by the MLO is of an operational nature only.
3. The Incident Controller will rely upon an officer from the local government to provide local knowledge and expertise in the development and provision of media releases and community information bulletins, for dissemination to the public through the local government, or DFES Media, as agreed at the time of the incident;
4. DFES may release media statements that reflect the Regional and multi agency perspective, of the status of fire incidents throughout the South West Region; and
5. DFES Media and Public Affairs may also be requested to release public information alerts through radio and television (in extreme circumstances) as well as updates on the DFES website and a recorded message dial in and dial out service.

**NB:** It is vital that timely and accurate information is relayed from the fire-ground to DFES Media and Public Affairs for this public alert system to be successful.



### 4.3 Recovery

The Emergency Management Act 2005 (*Section 36 (5)(b)*) legislates that it is a function of a local government to manage recovery following an emergency affecting the community in its district.

All recovery shall be conducted in accordance with the guidelines contained within the Shire of Donnybrook-Balingup Local Recovery Plan.

Recovery activities should begin to be planned during the incident, as soon as a community is identified as under threat.

Community Welfare and Recovery Plans should be prepared at the local level (through the Local Emergency Management Committee) with an established, prearranged structure that identifies the role of a coordinating recovery committee; and

The Department of Fire and Emergency Services may be represented on this committee.

Clean up the fire site and appropriately rehabilitate areas adversely affected by the fire or fire suppression activities. Close and rehabilitate any unwanted firebreaks during fire suppression activities.	Shire or DPaW
Consider safety of public facilities – close if unsafe	Shire
Consider restricting public access to the area until safe to enter. Possible burning Peat, trees etc	Incident controller
Check power lines for safety if in the fire area.	Synergy (Western Power)
